



NFT Marketplace Transaction Fees

Listing fees: Thoughtz NFT marketplace will act as a hub for thousands of Thought NFTs developed by content users. They are published in the marketplace and for highly promoted NFTs or to display in the top list, Thoughtz charges a small fee for promoted and sponsored NFTs.

Transaction processing charges: Peer-to-peer transactions are executed while buying and selling digital collectibles on NFT marketplaces. The investors generally pay through the leading cryptocurrencies, stablecoins, and social tokens. Thoughtz NFT marketplace selling platform imposes a transaction fee for each payment processed by the crypto investors. The transaction charges are imposed to pay off the gas charges for maintaining the functioning of the blockchain network.

Expert Marketplace Transaction Fees


TECHNICAL STACK

Blockchain

Blockchain is a decentralised system of recording and accounting for transactions. The "blocks" in this case are storage units storing digital information about transactions, such as the date, time, amount, and parties involved. Each block has its own unique code, known as a hash, which allows it to be recognized from the others.

New blocks are added to the end of a chain, which is a public database that everyone can examine when new transactions are made.

Blockchain technology is distributed over a peer-to-peer network of nodes, making it more anonymous and secure than previous payment methods. Hackers can't readily tamper with the data since each block carries a unique hash.

BSC

Binance is a blockchain that has decentralised, and centralised exchange functions built on top of it, which is known as the Binance chain. Binance Smart Chain is a solution built on top of the Binance Chain that improves the current chain's interoperability and programmability.

- 1. In contrast to Bitcoin's proof of work, BSC depends on proof of stake, which includes validators. Proof of stake is gaining traction in the crypto world, with new chains considering it for fresh block mining due to its cheap energy usage and computing capabilities.
- 2. Validators are the nodes that store the copy of all the blocks in their systems. They are responsible for the authentication and authorization of new blocks as well as protocols.
- 3. The USP of BSC is its 3 sec/block speed and lower transactional charges.
- 4. The presence of double sign-in detection and logic drastically increases the system's Security, Stability, and Chain Totality.
- 5. This transforms the BSC into a complete set of cross-chain automata.

NLP

Natural Language Processing, NLP, plays a very crucial role in the upcoming decentralised applications to analyse the text in their native languages to perform the data analysis for a better understanding and predictions. Since Thoughtz uses the text recommendations to match the users to experts, NLP will prove to be a blessing in disguise as it will improve the match-making algorithms and increase customer satisfaction.

Tensor Flow

Thoughtz uses advanced Tensorflow pre-trained models tested on trillions of data sets where it encodes text into high dimensional vectors that can be used for text classification, semantic similarity, clustering, and other natural language tasks. It comes with two variations i.e. one trained with Transformer encoder and other trained with Deep Averaging Network (DAN). The two have a trade-off of accuracy and computational resource requirement. While the one with the Transformer encoder has higher accuracy, it is computationally more intensive.

The pre-trained models in TensorFlow will give Thoughtz several steps ahead and massively help the match-making machine learning process. The availability of APIs and Java Scripts will swiftly adapt TensorFlow to any working environment.

Neural Search


Thoughtz's implementation of the Neural Network Searching Algo will help them make the perfect match by working with insufficient knowledge (THOUGHT KEYWORDS) along with the highest fault tolerance and to reach for a better result, Neural Search will use distributed storage to traverse better. Retrieving the right answer from any kind of data is crucial for all information systems. Traditionally the way to do this was using Symbolic Search – A keyword-based search that works on a fixed set of predefined rules. It works well for structured data, where you have a specific format, and you can store it using a relational database. Think of adding any animation, art images, movie, song, or video that can be stored along with its ID. So, all items can be paired with their IDs and easily retrieved when required using a simple set of rules.

But nowadays, we have more and more data of various types, including unstructured data. This data doesn't stick to one specific format, and it's not possible to store it using a two-dimensional tabular structure. Think of a video you saw on YouTube, and you remember a quote you would like to revisit, but you can't recall exactly what it was. But you remember a cat in the background, the exact moment of this quote. Neural Search would let you search through YouTube videos describing the scene you remember, making it more flexible and convenient than traditional Symbolic Search.
